

Routine Staff Testing Schedule

- ✓ The time your group gets tested may change. We will do our best to keep the groups in this order for all dates of testing. Please alert Shyann Topel or your supervisor of any issues with scheduling. If you have requested the date of testing off or have taken PPL you will need to visit with Kendra Hiles DON to get tested before or after your day off. All staff must be tested. Refusing to test will result in being excluded from work until tested.
- ✓ **Wear your PPE and practice 6 ft. social distancing.** If there is a line of staff waiting to be tested, wait in your car.
- ✓ For testing day only - park outside of the East Asst. living entrance on Yellowstone Trail. Enter at Door #19. Testing will take place in the East Asst. Living Dining area.
- ✓ Therapists and Hospice personnel should arrive between the hours of 1:30pm and 3pm. Any BLHCC staff currently working on the day of testing will be first priority.
- ✓ All staff will be compensated with one hour of pay if tested on the date and time scheduled.
- ✓ If you work a PM Shift this day you may come closer to your shift so you don't end up waiting to punch in.
